PAYMENT REGULARITIES

Producer agrees to be paid by client in either of the following standardized mechanism.

Method 1: Unlisted YouTube content by LIKES

1. Upon appearance of produced content on the client site (videos.myshop.cm), producer shall be entitled payment to every “LIKE” allocated to the content.
2. This payment shall be determined each month according to additional “LIKES” received by the specific content.
3. “LIKES” shall be multiplied by the number of content produced and placed on the client’s website (videos.myshop.cm) and payment calculated consequently.
4. Each “LIKE”, costing 10 CFA may be subject to negotiation during peak periods of the year.
5. Each Video content placed on the site shall require a subscription starting as from 1,000 cfa/video/month.
6. “Cost per Like (CPL)” is subject to increase proportionately with cost per video per month. E.g. if 1,000 cfa/video/month returns 10 cfa per like, then 2,000 cfa per video per month will return 20 cfa per like.

Method 2: Exclusive mTeeVee securely hosted video by VIEWS

1. Exclusive content hosted on our servers will cost 10,000 cfa per month per video and payment to producer shall be in terms of 1 cfa/per view per month.

QUALITY

It is the essence of this agreement that all completed media and services supplied by producer shall be of applicable production standards. Producer agrees that the media shall be of quality, artistically produced with direction, photography, sound, art, animation, synchronization and other physical and aesthetic content as agreed upon in the agreement.

PAYMENT REGULARITIES

Recording label agrees to be paid by client in the following standardized mechanism.

1. In order to sell, recording label must create a seller account which must be associated with a subscription plan. There are three main subscription plans including but not limited to; 10,000 CFA (10 Albums); 40,000 CFA (40 Albums) and 60,000 CFA (60 Albums). Subscription plan is one (1) year renewable.
1. Upon appearance of produced content on the client site (songs.myshop.cm), producer shall be entitled 75% of the payment to every “order” placed to the content.
2. This payment shall be recorded in their seller dashboard as well as other store statistics for accountability.
3. All payments are received by the platform and payable to the seller upon the placement of a withdraw request.
4. A withdraw request is only possible as from a threshold balance of 5000 CFA and exclusively payable via mobile money and the charges shall be incurred by the seller.

PAYMENT REGULARITIES

Event Planner agrees to be paid by client in the following standardized mechanism.

2. In order to sell, Event Planner must create a seller account which must be associated with a subscription plan. There are three main subscription plans including but not limited to; 5,000 CFA (500 Tickets); 10,000 CFA (1,000 Tickets) and 20,000 CFA (2,000 plus Tickets). Subscription plan is one (1) year renewable.
3. Upon appearance of tickets on the client site (tickets.myshop.cm), producer shall be entitled 85% of the payment to every “order” placed to the content.
4. This payment shall be recorded in their seller dashboard as well as other store statistics for accountability.
5. All payments are received by the platform and payable to the seller upon the placement of a withdraw request.
6. A withdraw request is only possible as from a threshold balance of 3000 CFA and exclusively payable via mobile money and the charges shall be incurred by the seller.

2. Upon appearance of written content on the client site (books.myshop.cm), producer shall be entitled 75% of the payment to every “order” placed on the book or script or copy.
3. This payment shall be recorded in their seller dashboard as well as other store statistics for accountability.
4. All payments are received by the platform and payable to the seller upon the placement of a withdraw request.
5. A withdraw request is only possible as from a threshold balance of 3000 CFA and exclusively payable via mobile money and the charges shall be incurred by the seller.

1. OWNERSHIP

Producer grants Client a one-year worldwide, non-transferable license to the Specified Media(s) and explicitly by signing this Agreement agrees not place the content or media(s) on any other online platform or Broadcast network including but not limited to TV channels.

2. SECURITY/CONFIDENTIALITY

Producer understands that some information for said media(s) may be of a confidential and/or sensitive nature. Producer agrees to require, within reason, those engaged for the production to sign appropriate agreements not to disclose or discuss information about the product or the specified media(s) in the usual and customary manner under this agreement.

3. INDEPENDENT CONTRACTOR

It is understood that producer's status under this agreement is that of an independent contractor and that all persons engaged by producer in performing its obligations shall not be deemed employees of client.

4. TAX LIABILITIES

Any sales tax, use tax or other tax payable on delivery of specified media(s) to client(s) (other than sales tax arising from producer's supplies in connection with production) shall be the responsibility of client who shall pay, defend and hold harmless producer from payment of any such taxes.

5. ALTERATIONS

Any alterations of original art (color shift, mirroring, flopping and paste) creating additional art is prohibited without the express permission of producer. Producer will be given first opportunity to make any alterations required. Unauthorized alterations shall constitute in additional use and will be billed accordingly.

6. ENTIRE AGREEMENT AND MODIFICATION

This Agreement shall constitute the entire agreement between producer and client. Any amendment hereto must be in writing and signed by each party.

7. APPLICABLE LAW

This Agreement shall be interpreted and governed by the local laws of the jurisdiction where the production company office authorizing this Agreement is located.
